Dear Pleasant Grove Camp Meeting Family,

It is with great disappointment that we advise that there will be no 2020 Camp Meeting.

In our efforts to comply with CDC and North Carolina guidelines, to consider our staff, pastors, campers and community, we determined that the only camp meeting we could put together this year would be a limited worship experience, one that could not include a children's program and crafts, no choir or congregational singing, no Stand, no watermelon, no ice cream, no water fight, no Saturday Games.

To be responsible under Phase 2 guidelines, we would be required to wear masks, sanitize and socially distance for worship. Family groups would need to stay together and not mingle or share meals. No playground equipment (swings, slides, volleyball). Many of our families and staff let us know that they would not attend due to Covid-19 concerns.

Trustees pondered a camp meeting under these restrictions and felt it just would not be camp meeting without all the traditions and worship experience we have come to love and associate with camp meeting. For these reasons, Trustees decided to cancel Camp Meeting 2020.

Tent Usage Under CDC and North Carolina Guidelines

We are aware that many of you have planned your vacations around camp meeting and may plan to use your tent for family gatherings during camp meeting week. We ask that you please be respectful of the CDC guidelines while on the grounds (remain socially distanced/wear mask, sanitize, and do not exceed the recommended gathering of people). Please also continue to respect campground rules for an orderly camp meeting (attached).

If North Carolina Phase 2 guidelines are still in effect, please be advised that playground equipment, swings, volleyball will not be available for use.

There will be no garbage pick up available, so please remove any garbage with you when you leave the grounds.

Tentholders Meeting Canceled

There can be no Tentholder Meeting this year, as it would exceed maximum gathering guidelines.

Tent Assessment Fee: \$500

As you know, this assessment covers our operating costs of annual maintenance, mailings, mowing, water, electric, as well camp meeting week staff and pastor salaries. We respectfully ask that you pay at least a minimum of \$350 toward our annual expenses. Please pray, and if you feel so led to support camp meeting with the full \$500 tent assessment, it would be much appreciated to cover lost collections.
